FIRE DEPARTMENT—Alderman Parmley made a motion to get a Visa card through Citizens Tri-County bank for fire department purchases. It will have a credit limit of \$5000.00. Alderman Orr seconded the motion and it passed 5/0. Chief Phillips reported that they are working on mapping.

ROADS—Grundy County Highway Department will be working on Wrens Nest Road in March or April of this year.

BUSINESS PERMITS—Both permits will need to go to the Planning Commission before approval. Phat Boy BBQ, a mobile food vendor, and Mountain Archery.

RESOLUTION 14-01—MEDICAL INSURANCE FOR THE CITY COUNCIL—There was discussion with no motion being made.

RESOLUTION 14-02—COMMUNITY BLOCK GRANT—Alderman Leonard made a motion to pass resolution 14-02, a grant for rehabilitation of the water

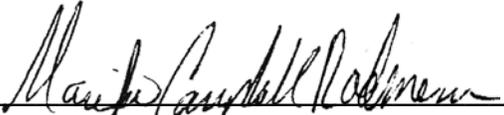

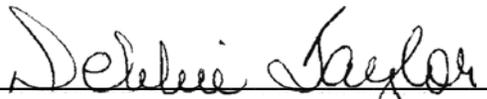
