Mr. Gifford's Contractor agreed to contact Mr. Angel Wednesday morning and arrange to meet him at the jobsite to discuss a final approval from T.D.O.T.

Once this approval was obtained, Mr. Gerry will be in a position to issue Mr. Gifford a Certificate of Occupancy for his business.
