This is the old bank building next to the Annex.

SECOND READING OF ORDINANCE 01-17 – This ordinance is to amend the Capital Asset Replacement Fund by \$ 42,500 to provide additional funding for the purchase and equipping of an operational building for the Police Department. Alderman Blalock made a motion to approve this ordinance on second reading. Alderman Knott seconded the motion and it passed 4/0.

SECOND READING OF ORDINANCE 21-16 – An ordinance to abandon two unnamed, unopened alleys between U. S. Hwy 41A and First Street. This property belongs to Mr. Richard Partin. Alderman Knott made a motion to approve this ordinance on second reading. Alderman Gipson seconded the motion and it passed 4/0.

PURCHASE OF THE BUILDING FOR THE POLICE DEPARTMENT -The city would like to purchase the old bank building on College Street
for the Police Department. The cost is \$ 190,000. Alderman Blalock
made a motion to purchase this building. Alderman Gipson seconded
the motion and it passed 4/0.

PURCHASE OF A NEW UTILITY TRUCK – There was discussion on purchasing a new vehicle for the utility department. We have three bids for the truck. Gentry Chevrolet for \$ 31,023.01, Moss Motors for \$23,874.53 and Russell Barnett for \$ 23,801.00. Alderman Knott

made a motion that we accept the bid from Russell Barnett for \$ 23,801.00. Alderman Blalock seconded the motion and it passed 4/0.

DE-ANNEXATION OF DEEPWOODS – Mr. Bob Childers was present and made a request to have the rest of Deepwoods deannexed. There will be a Public Hearing on February 13th for the first reading of the ordinance to de-annex this area. The second reading will be at the regular monthly meeting on February 27th.

INTER-LOCAL GOOPERATION AGREEMENT 12TH JUDICIAL DISTRICT DRUG AND VIOLENT CRIME TASK FORCE — Chief McNeece reported that this is an agreement that is done every year. Alderman Blalock made a motion to approve this agreement. Alderman Knott seconded the motion and it passed 4/0.

FIRST READING OF ORDINANCE 02-17—This ordinance is to amend the General Fund to provide a clerical position. Mayor Sampley explained that this position will be to help the Chamber of Commerce, make calls to the elderly, help with events and clerical for the State septic reports. Alderman Knott made the motion to approve this ordinance on first reading. Alderman Blalock seconded the motion and it passed 4/0.
