
**SECOND READING OF ORDINANCE 18-21 NONCONFORMING USES –** This ordinance reading was tabled to the next meeting.

Fire Department Report  
August 30, 2021

There are several projects I would like to present this evening as well as some other areas of importance – in no order of importance.

This past Friday, August 27<sup>th</sup>, a fire drill was conducted at and by the students, faculty, and staff of Monteagle Elementary. Chief Brewer was responsible for the coordination with 911 dispatch to insure they knew it was an in-house drill. Chief Brewer and Assistant Chief Lawyer brought the 2 fire trucks to the school and observed the building evacuation. They then made recommendations to the staff which will be incorporated into the school's crisis response plan. We will be working with Monteagle Elementary, Signature Health Care of Monteagle, and the apartment complexes regarding hydrant and evacuation details. All business entities should give thought to their evacuation plans, signage, emergency lighting, and whatever is necessary in their establishment to protect their employees and customers.

You probably know that the truck we were hoping to purchase is no longer available. The Chief and Assistant Chief have been searching for another rescue/pumper within the price range and having similar specifications. They and I have researched many various entities to buy the red tagged truck but to no avail. [Comments have been too old or only buy to trade or we'll try to sell it for you on a brokerage basis]




The Chief and Assistant Chief have been collaborating on several operational procedures using ISO requirements. One such document is the hydrant testing program which is in your packet. Monteagle Volunteer Fire Department will be hosting a class on proper testing and maintenance procedures of hydrants. The class will be held September

7<sup>th</sup> at 6 PM. Other fire departments will be joining our firefighters in this very important project. Of course, this project will be coordinated with the town's water department. Any water department personnel are welcome to attend the training session. There are approximately 228 hydrants in the water district.

The Department leadership has been writing training and recruitment procedures tailor made to the Monteagle Volunteer Fire Department. As I am sure you know, Monteagle has no such documents that any of us are aware. We are at the first step of a complex and detailed journey. You see all such documents must comply with approved fire science requirements. They are detailed as to the type of training, the hours required, and the time to perform certain tasks. All of this is recorded and maintained as inspectable items during an ISO visit.

We continue to file and follow up on structure and truck fire insurance incidents.

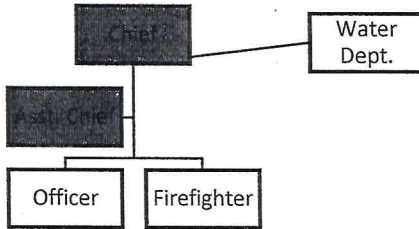
Of course, all of this takes time to research, review, implement, record, and continue on a specific basis. What the Department Leadership is doing is far and above their pay grade which was established years ago when none of these tasks were addressed.

**1.0 Purpose**

The purpose of this standard operating procedure is to ensure MFD has and operates an effective Annual Fire Hydrant Flow Test and Maintenance Program for the town’s hydrant system. This procedure will address; annual flow testing and gathering of flow data, annual maintenance; including exercising, inspections, lubrication, and general painting, and NFPA 291 Guidelines. The gathered annual information will be used for bettering and improving our demographics as a fire department and ISO reporting for a better and improved overall score based toward the water distribution factor of the ISO. Current preliminary counts indicate the town of Monteagle has a close estimate of 228 fire hydrants.

**2.0 Key Personnel Involved**



The listed chart shows visual responsibility of personnel involved in this procedure. The Chief and Assistant Chief will be ultimately responsible and key contacts regarding this SOG. The chief officers will be responsible for overseeing the annual schedule of hydrant flow testing, data entry, and record keeping for departmental and town findings to report to all requesting agencies for inquiry purposes. The firefighters / members of the department will be responsible for the labor in flowing, inspecting, and servicing all town hydrants other than mechanical repairs, which will be then tagged for water department review. The report from the fire department, will then be given to the water department / superintendent.

### 3.0 Procedures

#### Article I. Fire Hydrant Color Code System and Flow Rates; Per NFPA 291

- All fire hydrants in the city's water district will follow color coding based on NFPA 291 recommended guidelines. The following is the color system to be used for the town's hydrants. The bonnet top and nozzle caps shall be color coordinated to follow such guideline for fire department and flow identification.
- The barrel of the hydrant shall be painted yellow, per municipal standards. The bonnet top and nozzle caps will be painted based on the fire flow calculated from that prospective hydrant.

| COLOR  | CLASS | AVAILABLE FLOW @ 20 PSI Residual |
|--------|-------|----------------------------------|
| BLUE   | AA    | 1,500 GPM or greater             |
| GREEN  | A     | 1,000 – 1,499 GPM                |
| ORANGE | B     | 500 – 999 GPM                    |
| RED    | C     | Below 500 GPM                    |

#### Article II. Annual Flow Testing

- Beginning in March each year, members of the fire department will begin annual flow testing of the town's fire hydrants. The hydrant flow schedule will be based on breaking the town into sectors to efficiently perform the task. The fire chief or his/her delegate will then coordinate with the water superintendent, a schedule of the amount of hydrants to be flowed for the given date to ensure the water delivery is sufficient enough to handle the extra flow loss of the flow testing. Each date the fire department plans to flow test, the water department must be notified the morning of to ensure water is available for the testing. The testing should be conducted per direction of the chief until all city hydrants have been tested and logged for that calendar year.
- Using the department provided hydrant flow spreadsheet, and flow testing equipment members will flow each hydrant in the town and record test hydrants using the 2 nominal hydrant procedure. The readings will include; static pressure, residual pressure, and pitot pressure, along with the coefficient of the hydrant. Each of these shall be entered into the spreadsheet for flow calculations.
- The field entered spreadsheet should then be given to the chief and/or assistant chief for electronic data entry into the hydrant log and mapping.
- Members will be issued a set number of hydrants in a set area to do as a part of their monthly training as required.
- There are an estimated number of 228 known hydrants within city limits



### Article III. Annual Fire Hydrant Maintenance

- Along with the annual fire hydrant flow testing, members flowing the hydrants will also inspect and service the hydrant. The task associated with this article will ensure that each hydrant within the city is physically inspected for; paint and color coordination to the flow, general exercising, (turning and working the hydrant open and close) removing, lubricating, and cleaning all cap/nozzle threads, greasing/oiling the bonnet grease/oil plug per manufacture specifications, checking the hydrant for overall function, and tagging/reporting a faulty hydrant if needed.
- For painting; the member shall ensure the hydrant is properly prepped and cleaned to paint. The bonnet and nozzle cap paint color shall be required NFPA color. The paint used shall be a brush on, oil-based paint. Members shall loosen the cap and ensure no moving part of the hydrant is "painted shut" or otherwise stuck from painting. While painting, members shall exercise due caution and regard to ensure there is no citizen or private property damages resulting from "sloppy painting."
- For greasing/oiling; members shall use manufacture recommended "food grade" grease / oil, depending on what the hydrant requires, and follow all precautions and guidelines while doing so.
- Exercising; after lubricating the hydrant, the member shall open and close the hydrant fully, with the caps in place and ensure the proper function and movement of the stem. All caps/nozzles shall also be turned to ensure the function and seal of them.
- Once the maintenance tasks are completed, the member shall mark the box on the spreadsheet, verifying the maintenance portion has been properly completed.

### Article IV. Out of Service (OOS) Hydrants

- A hydrant that fails flow testing and or maintenance and inspection may be required and deemed out of service by the member administering the testing. If this happens, the member shall notify the chief / assistant chief immediately of his/her findings.
- A report will be given of the problem and the chief and or his/her delegate will notify the water department of the department and verbally explain the findings and problem with the said hydrant. Any detailed repair and or maintenance must be conducted by the water department and not performed by fire department members due to the liability.
- In the event a hydrant is taken out of service, members should notify the chief and or assistant chief ASAP.
- The member shall then place a garbage bag over the top of hydrant and secure with duct tape until the noted issue has been resolved.
- Once a hydrant has been tagged out of service, the chief or assistant chief shall log it in the "hydrant mapping" plan and notify dispatch of the hydrant and location being out of service.
- As soon as an all clear / repair has been made to the out of service hydrant, the chief or assistant chief shall update the hydrant mapping plan and notify dispatch of the hydrant and location being back in service.
- A log for the out of service hydrant shall be kept hydrant master log. All repairs shall be logged for the hydrant.

Attached are the renderings for the first version of the design for Hannah Pickett Playground.

We went ahead and designed the entire area out based on our conversation.

Phase 1 would include the 5-12 yr old structure (which is the design you liked when we met), the inclusive Oodle Swing (disc swing), 2 bays of swings, mulch and border timbers for this initial area, and install. Our estimator is waiting on one more number and then we'll have our proposal over to you. This phase is estimated to be around 50k-55k.

Phase 2 would expand the overall area and add the 2-5 year old structure, expand the 5-12 area w/ some free standing spinners, and all the outdoor fitness equipment off to the side.

9:03 am: Hijackers deliberately crashed United Airlines Flight 175 into floors 77 through 85 of the South Tower.

9:37 am: Hijackers deliberately crashed American Airlines Flight 77 into the Pentagon near Washington D.C.

9:59 am The South Tower collapsed.

10:03 am After learning of the other attacks, passengers on United Airlines Flight 93 launched a counterattack on hijackers aboard their plane to try to seize control of the aircraft. In response, the hijackers crashed the plane in an empty field near Shanksville, Pennsylvania.

10:28 am: The North Tower collapsed.

In closing:

The [September 11](#) attacks were a series of four coordinated terrorist attacks upon the United States on [September 11, 2001](#).

The attacks resulted in 2,977 fatalities, over 25,000 injuries, and substantial long term health consequences. In addition to at least \$10 billion infrastructure and property damage. It was the deadliest terrorist attack in human history and the single deadliest incident for firefighters and law enforcement officers in the history of the United States.

On that morning, 19 Islamist terrorists affiliated with al-Qaeda hijacked four commercial passenger jet airliners. The hijackers intentionally crashed two of the airliners into the Twin Towers of the World Trade Center in New York City, killing everyone on board and many others working in the buildings. Both buildings collapsed within two hours, destroying at least two nearby buildings and damaging others. The hijackers crashed a third a third airliner into the Pentagon. The fourth plane crashed in a field that was directed toward Washington D.C. There were no survivors from any of the flights. The United States responded to the attacks by launching a "War on Terrorism" invading Afghanistan to depose the Taliban, who had harbored al-Qaeda terrorists, and enacting the USA PATRIOT ACT.

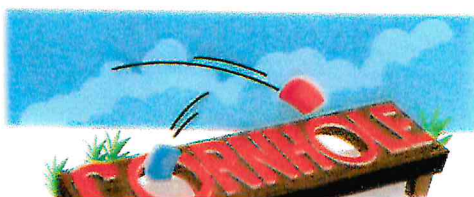
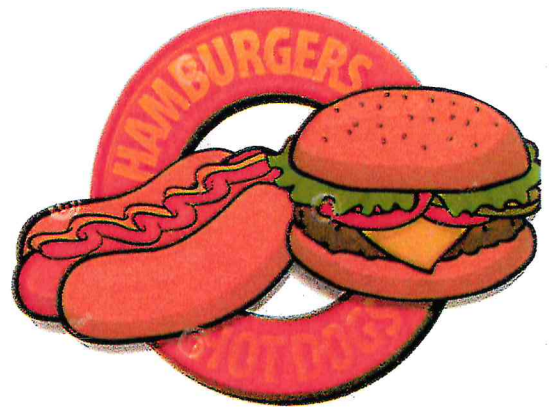
